Tábhacht an Pholasaí

Coláiste Pobail Osraí Enrolment Policy



The Enrolment Policy of Coláiste Pobail Osraí has been formulated in accordance with the provisions of the Education Act 1998, The Education Welfare Act 2000, and the Equal Status Act 2000 in order to assist Parents and Guardians of prospective pupils in relation to enrolment matters. The Principal, as Secretary to the Board of Management will be happy to clarify any further matters arising from the policy.

Relevance of Policy.

The fulfilment of the aims of the school depends on the active support of all the partners within the school community. It is of vital importance, therefore, that parents and students who are about to attend the school will understand the nature of the school, its aims, its ethos and how it may benefit their children. The entrance procedures and its various elements are an essential part of a process to create this insight and understanding.

Coláiste Pobail Osraí is an all-Irish, co educational school. The main differences between ourselves and other schools are;

- 1. Gaeilge is the language used in any communication among pupils and teachers in the school environment.*
- 2. Gaeilge is the language used among pupils and teachers on school activities outside of school.*
- 3. All subjects are taught through the medium of Irish except for languages in which the direct method is used.*
- 4. We endeavour to create an atmosphere which will encourage a respect for the worthwhile aspects of our culture and tradition, , music, dancing, sport, art and architecture etc as well as giving them confidence in their own worth.*

- All applications must be made on an official school application form
- Closing date for applications for places is the first Friday of October.
- Parents will be notified as soon as possible thereafter whether they have a place or not.
- If vacancies remain late applications will be accepted.

Students coming into first year

Places are allocated in the following order:

- 1 Sisters/Brothers of students who attend or have attended Coláiste Pobail Osraí**
- 2. Children of staff of Coláiste Pobail Osraí**
- 3. Children of past pupils of Coláiste Pobail Osraí**
- 4. Boys/Girls attending Gaelscoil.**
- 5. Children who come from Irish speaking homes.**
- 6. Pupils from English medium primary schools provided their standard of Irish is sufficiently high. Students will have a short interview and written exam to assess their level of Irish.**

- If selection has to be made within a particular category preference will be given to students from Irish-speaking homes. Remaining places will be allocated by lottery.
- No places will be offered above 1st year except in classes with fewer than 24 students.
- If places are available, applicants will be interviewed to make sure their level of Irish is appropriate for the class they wish to join. The level of competency will be assessed through an oral and written assessment.
- Students who leave the school cannot be guaranteed re-admission.
- Parents will be informed when being offered a place that Coláiste Pobail Osraí is an all-Irish school and in accepting a place in the school, they are also accepting this ethos.

Late Application /Application to join a class other than first year

- Students will only be considered if there are spaces in the class and after the student has been interviewed, and satisfy the above criteria.
- Students must demonstrate a suitable proficiency in Irish to the particular year they are entering so that they can participate in the teaching and learning in the School. The level of competency will be assessed through an oral and written assessment

Students transferring from English medium Primary Schools

- Students will only be considered if there are spaces in the class, they are applying for, and after the student has been interviewed, and satisfy the above criteria.
- Students must demonstrate a suitable proficiency in Irish *to the particular year they are entering* so that they can participate in the teaching and learning in the School. The level of competency will be assessed through an oral and written assessment.
- It is highly recommended, if not essential, that students should improve their fluency in the Irish language by attending courses and practicing the language.

Students transferring from other Post Primary schools

- Students will only be considered if there are spaces in the class, they are applying for, and after the student has been interviewed, and satisfy the above criteria.
- Students must demonstrate a suitable proficiency in Irish to the particular year they are entering so that they can participate in the teaching and learning in the School. The level of competency will be assessed through an oral and written assessment.
- It is highly recommended, if not essential, that students should improve their fluency in the Irish language by attending courses and practicing the language.

Under the terms of Section 29 of the Education Act parents have a right to appeal the decision of the Board of Management in relation to admissions. This appeal must be lodged with the Department of Education & Science within 42 days of notification of the board's decision.

This policy will be reviewed regularly.
