

# Polasaí Úsáide Inghlactha an Idirlín/iPad/Teicneolaíocht

## ***Acceptable user policy for internet/iPad/Technology***

Is e aidhm an pholasaí ná a chinntiú go mbainfidh daltaí leas foghlama as achmhainní idirlín na scoile ar bhealach sábháilte agus éifeachtach. Is uirlis múineadh agus foghlama é an iPad, le n-úsáid don chúis sin.

*The policy aims to ensure that students benefit from the school's internet resources in a safe and effective manner. The iPad is a teaching and learning tool and should be used as such.*

## **Conradh**

- Ní ghlacann Coláiste Pobail Osraí freagracht ar bith maidir le cailteanas ná le dochar don iPad san áitreabh scoile (*Coláiste Pobail Osraí accepts no responsibility for loss or damage of iPads on school property.*)
- Fút féin atá sé d'iPad a luchtú sa bhaile chun a bheith réidh lena úsáid ar scoil (*Students are responsible for having a fully charged iPad for use in school*)
- Is áis oideachasúil é an iPad don fhoghlaim (*The iPad is an educational resource to assist learning*)
- Tá cosc ar ghrianghraf nó fíis a thaifead sa seomra ranga nó áit ar bith eile sa scoil gan cead an mhúinteora (*Recording photos, videos and audio recordings are prohibited in classroom or anywhere in the school unless with teacher's permission.*)
- Tá cosc iomlán ar theachtaireachtaí a sheoladh le linn am scoile (*Sending of messages is prohibited during school hours*)
- Níl cead aipeanna meáin sóisialta a úsáid le linn am scoile. Caithfidh na haipeanna seo a bheith dúnta roimh 8:50 ar maidin (*No social media app is permitted to be used during school time. These apps must be closed by 8:50am everyday so teachers can monitor this*)
- Níl cead an aip "Snapchat" nó a leithéid a bheith ar an iPad ar chor ar bith i rith na scoilbliana. (*Students are not permitted to have "Snapchat" or similar apps, on their iPads during the school year*)
- Nuair a dheireann an mhúinteoir "thart agus as" caithfear an iPad a mhúchadh, an clúdach a dhúnadh air agus é a leagadh anuas ar an mbord. (*iPads must be shut down and laid down flat with a closed cover on the table when the teacher says "thart agus as"*)
- Níl cead aon aipeanna nach bhfuil ceadaithe a íoslódáil ar an iPad (*Apps that are not permitted may not be downloaded to the iPad*)
- Níl sé ceadaithe cluichí a imirt ag aon am ar scoil. (*Students are not permitted to play games on their iPads at any time during the school day.*)
- Tá cead ag aon múinteoir seic a dheanamh ar d'iPad ag aon am agus caithfidh an dalta iad a thabhairt don mhúinteoir láithreach má iarrann sé/sí orthu é a dheanamh. (*iPads may be checked by the teacher at any time and must be surrendered immediately upon request*)
- Níl cead aon ábhar mhídhleathach a sheoladh ná a íoslódáil (*no illegal material may be downloaded, uploaded or sent*)

- Ní fhoilseoidh daltaí a sonraí pearsanta féin ná sonraí daoine eile, nithe mar sheoltaí nó uimhreacha fóin nó pictiúir (*Students will not publish their own or others' personal details such as addresses, phone numbers or pictures*)
- Coinnígí bhur ríomhphoist scoile do obair oifigiúil scoile amháin (*School email should be used for official school work alone*)
- Níl sé ceadaithe an iPad a úsáid roimh scoile, ag an sos nó ag am lóin seachas le cead sainiúil ón mhúinteoir. (*iPads may not be used before school at breaktime or at lunchtime except with the permission of a teacher.*)
- Seasann na rialacha seo don teicneolaíocht sa scoil nó ag aon imeacht scoile taobh amuigh den scoil freisin. (*These rules apply to use of technology on school grounds or at any school related activity*)
- Níl cead ag na daltaí fón póca a úsáid sa scoil ag aon am ach amháin má tá gá dul i dteagmháil le tuismitheoirí/caomhnóirí ag **am lóin**. Is féidir cead speisialta a fháil ó mhúinteoir teagmháil a dhéanamh le tuismitheoirí/caomhnóirí i rith am ranga le guthán na scoile. Ba chóir go bhfuil an fón póca múchta sna ranganna. (*Students are not permitted to use phones while in school, except in the case of emergency to contact parents/guardians **at lunchtime**. Special permission may be obtained from a teacher to contact parents/guardians during class time through use of the school phone in the office. Phones must be turned off in all classes*)

Is féidir le bainistíocht na scoile cosc a chur ar roinnt aipeanna le linn na scoilbhliana. (*The school management reserves the right to ban various applications that the school may deem inappropriate within the school year*)

Má beirtear ar scoláirí ag sárú aon cheann de na rialacha sin thuas córas smachta na scoile in úsáid (*Any student found breaking any of the above rules will be subject to the school's code of discipline*)

### **Dalta**
